HUNTER EDUCATION REQUIREMENT: Any hunter born after December 31, 1961 must submit with this hunting application a **copy** of their certification verifying that he/she has completed a course in hunter education from any tribe, state, or province. Any applications submitted without a copy of their hunter education certification will be rejected. **EXCPTION:** Youth age 11 and younger who have not yet taken a hunter education course.

Hunter Status

- TAT Youth Tribal Member** – Youth age 15 and younger who is enrolled with the Three Affiliated Tribes.
- Non-Member Resident Youth** – Youth age 15 and younger who is living within the boundaries of the Fort Berthold Reservation but is not an enrolled member of the Three Affiliated Tribes.
- Non-Member Non-Resident Licenses** – Youth age 15 and younger who is neither an enrolled member of the Three Affiliated Tribes nor lives within the boundaries of the Fort Berthold Indian Reservation.
